# TAXICAB ORDINANCE CHAPTER 124

Public Services Committee Feb. 13, 2013

#### § 124.003: Frequency of Inspection

- Requires that an owner conduct "thorough, periodic inspections of each of his/her vehicles.
- Inspection once every three months or every 3,000 odometer miles, whichever is first.
- Records of inspections, deficiencies and corrections must be kept by owner.
- These records shall be open to inspection by city at any time to determine compliance.

#### **Inspection Proposal**

- Require a certified mechanic complete and sign vehicle inspection form.
- Taxicabs would be responsible for paying mechanic.
- Additional inspection items: Taximeters, Seatbelts, etc.

#### § 124.005: Surcharge

- Surcharge of \$.10 per trip for every increase of \$.15 in the price of gasoline over \$1 may be charged in addition to the above. Currently \$1.30
- If the price of gasoline is reduced, the surcharge shall be reduced accordingly.
- Documentation justifying the increase shall be provided to the City approved by the City Planning Office.

## Surcharge Proposal

- Reassign responsibility to Licensing Specialist.
- Quarterly or semi-annual surcharge notices to taxicab companies.
- Notice initiated by Licensing Specialist.

License required for operating a vehicle for hire upon the streets or act as a driver of any such vehicle for hire. § 124.025 & § 124.028.

# Other Proposals

- Consider additional insurance for taxicabs who choose to serve alcohol.
- Add penalty fee for failure to renew on time.
- Fix Contradiction: The maximum fare is based on 5 passengers or less, but Taxicab is defined as seven passengers or less.
- Define Passenger Service Vehicle: any motor vehicle carrying passengers for a fee and by appointment, but shall not include any vehicle defined as a limousine.

## Other Proposals

- Develop guidelines for employment of drivers.
- Requires a rate card that is conspicuous.
- Fraud/Complaint Hotline.
