# SOUTH DAKOTA OPEN MEETING COMPLAINT

The City of Sioux Falls individually and collectively through the City Council, violated South Dakota Open Meeting Laws on November 16th, 2021 during the regular Sioux Falls City Council meeting.

#### **Affidavit of Sierra Broussard**

- I, Sierra Broussard, being duly sworn upon my oath, deposes and states as follows:
  - 1. I am a citizen and voter with residence in the city of Sioux Falls, SD.
  - 2. I live in the central Sioux Falls neighborhood locally recognized as Pettigrew.
  - 3. I am the elected President of the Pettigrew Neighborhood Association.
  - 4. I am a longtime citizen activist on crime, policing and neighborhood issues.
  - 5. I am not an attorney or trained in the law.
  - 6. I have been concerned about crime issues involving bars in downtown Sioux Falls.
  - 7. I am a concerned citizen who has had rights violated by the Sioux Falls City Council, City Clerk, City Council Chair and the Mayor acting in his position as presiding officer of the Council on the night in question.
  - 8. I am filing this affidavit to document activities I witnessed or was party to, involving the Sioux Falls City Council Meeting of November 16<sup>th</sup>, 2021 I believe violated the letter and spirit of the South Dakota Open Meetings Laws, under SDCL 1-25, 1-27 and others not mentioned.
  - 9. Sioux Falls is a Home Rule Charter municipal government organized under the laws of the State of South Dakota.
  - 10. The Sioux Falls City Council consists of 8 members and the non-voting (unless there is a tie vote to break) mayor.
  - 11. The Sioux Falls City Council is chaired by the mayor, Paul TenHaken.
  - 12. The Sioux Falls City Council agenda and minutes are managed and recording by the City Clerk, Tom Greco.
  - 13. By Charter the Sioux Falls City Attorney is the attorney for the City Council and the mayor.
  - 14. The City Attorney is required to be at all City Council regular meetings.
  - 15. The Sioux Falls City Attorney is Stacy Kooistra.
  - 16. The City Council elects one of its members to be Chair of the body and in charge of the meetings when the mayor is absent.
  - 17. The Sioux Falls City Council Chair is Curt Soehl.
  - 18. Sioux Falls City Council meetings, by ordinance, must follow the latest edition of Robert's Rules, unless there is a conflict with state law, city ordinance or Charter.
  - 19. The Sioux Falls City Council has regularly scheduled Tuesday meetings at 6:00 pm in the Carnegie City Council Chambers the first three Tuesdays of each month.
  - 20. The state of South Dakota requires local government meetings to offer the public opportunities to give public input during meetings.
  - 21. Sioux Falls City Council has general public input at every regular meeting.
  - 22. Sioux Falls City Council requires public input on all 1<sup>st</sup> and 2<sup>nd</sup> reading agenda items and all consent items called for discussion and separate votes.

- 23. I am a regular speaker during general and agenda item public inputs.
- 24. My general and agenda item public inputs regularly consist of crime, policing and neighborhood issues.
- 25. During the annual liquor license renewal process I noted a certain license involving David's Bar located in downtown on 11<sup>th</sup> St. across from the City Council building.
- 26. There was an assault incident at the bar involving an underage patrons and lethal weapons in September, 2021.
- 27. The bar was up for license renewal before the City Council on November 16th, 2021.
- 28. The license renewal I wanted to discuss was part of a list of at least 250 liquor and video lottery establishments requiring a vote of the City Council.
- 29. I contacted Jamie Palmer, city of Sioux Falls Licensing Specialist for procedures on how to speak to my issues.
- 30. Since the September incident, I have talked with many individuals including Councilors Greg Neitzert, Curt Soehl and Pat Starr plus Bruce Danielson and Licensing Specialist Jamie Palmer among others.
- 31. I announced in the days prior to the November 16<sup>th</sup>, 2021 meeting, my opposition to a consent agenda vote on that license without any discussion.
- 32. I contacted Sioux Falls City Council member Pat Starr and asked him to pull the liquor license renewal from the consent agenda to the regular agenda so the public would be allowed to have public input.
- 33. When asked by me, Council member Pat Starr agreed to pull the David's Bar sub item for discussion and vote.
- 34. As part of the rules and procedures for the City Council meeting, the City Clerk / city administration must be informed by Monday at noon, prior to the Tuesday meeting, if the Council member wishes to question city staff during a meeting.
- 35. Council member Pat Starr told me he did request, as required, the following be available for questioning: Health Director Dr. Chima for sub item 7 and someone from the police department to discuss sub item 12, exhibit C, DCK, LLC for discussion and separate vote.
- 36. In preparation for the meeting, I contacted the Sioux Falls Police department on the prior Friday, November 12, 2021, to get a copy of the incident call logs for David's Bar.
- 37. I picked up the incident call log records at the police station on Tuesday November 16<sup>th</sup>, 2021 at 7:45am.
- 38. Councilor Pat Starr stated during a conversation that he had requested a copy of the call logs for David's Bar.
- 39. Minutes before the November 16<sup>th</sup>, 2021 City Council regular meeting, I asked Council member Pat Starr if he had received a copy of the police logs and he told me he hadn't, so I gave him a copy of it for his use during the process.
- 40. Due to consistent video failures of the Sioux Falls city website, I will reference video timestamps from an independent 3<sup>rd</sup> party website <a href="www.siouxfall.org">www.siouxfall.org</a>, archived on <a href="www.youtube.com">www.youtube.com</a>.

- 41. A complete archived video for the November 16<sup>th</sup>, 2021 meeting in question, 2021-11-16 Sioux Falls City Council Meeting, is <a href="https://youtu.be/-bSgqDzUyMo">https://youtu.be/-bSgqDzUyMo</a>.
- 42. The City Council met as scheduled on November 16<sup>th</sup>, 2021 at 6:00pm with Mayor Paul TenHaken as chair or presiding officer.
- 43. All City Council members were in attendance
  - a. Council member Curt Soehl Chair
  - b. Council member Alex Jensen Vice Chair
  - c. Council member Greg Neitzert former Chair of City Council
  - d. Council member Marshall Selberg former Chair of City Council
  - e. Council member Christine Erickson former Chair of City Council
  - f. Council member Council Member Rick Kiley former Chair of City Council
  - g. Council member Janet Brekke
  - h. Council member Patrick Starr
- 44. City Clerk Tom Greco and Council parliamentarian was in attendance on the dais documenting the proceedings.
- 45. City Attorney Stacy Kooistra was in attendance on the dais to answer legal questions or legality of issues that might arise.
- 46. At 6:26 minutes (<a href="https://youtu.be/-bSgqDzUyMo?t=386">https://youtu.be/-bSgqDzUyMo?t=386</a>) into the meeting, the Chair turned to Council member Starr so he could request separate discussion on two items he wishes placed on regular agenda.
- 47. Council member Pat Starr did place the Consent Agenda sub item 7 vaccines and sub item 12 exhibit C DCK, LLC. from the consent agenda to the regular agenda. <a href="https://youtu.be/-bSgqDzUyMo?t=372">https://youtu.be/-bSgqDzUyMo?t=372</a>
- 48. The City Council voted and passed the Consent Agenda without the noted sub items.
- 49. Excerpt from the Clerk's posted minutes:
  - 5. APPROVAL OF THE CONSENT AGENDA

A motion was made by Council Member Selberg and seconded by Council Member Jensen to approve the Consent Agenda.

A request was made by Council Member Starr to place Sub-Item18 from Agenda Item 7 and DCK, LLC from Exhibit C to Agenda Item 12. on the Regular Agenda for Council Discussion (Health; Agreement to provide process and impact evaluation of the City Covid-19 vaccination efforts; University of South Dakota; Not to Exceed \$23,863.00 \* DCK, LLC; David's; 212 W. Tenth St.). See Agenda Items 7 and 12 for actions taken.

Roll call vote to approve. 8 Yes: Starr, Brekke, Erickson, Jensen, Kiley, Neitzert, Selberg, Soehl; 0 No: (None). **Motion Passed.** 

50. At 7:58 minutes into the meeting, meeting chair Paul TenHaken read the rules for public input (<a href="https://youtu.be/-bSgqDzUyMo?t=478">https://youtu.be/-bSgqDzUyMo?t=478</a>):

- a. "before we move on with our meeting just a reminder how public input works for our meetings uh for any item that we're reviewing comments are limited to three (3) minutes unless it's for final adoption in that case uh public input comments are limited to five (5) minutes uh items are also limited to the agenda item under consideration only for the comments and at the end of the meeting at general public input uh people will be allowed three minutes per person for input"
- 51. At 8:23 minutes into the meeting (<a href="https://youtu.be/-bSgqDzUyMo?t=503">https://youtu.be/-bSgqDzUyMo?t=503</a>), sub item 18 is called for discussion by the Chair and Clerk
- 52. Questioning and discussion of sub item 18 ends when presiding officer TenHaken calls for a motion at 12:24 (<a href="https://youtu.be/-bSgqDzUyMo?t=503">https://youtu.be/-bSgqDzUyMo?t=503</a>) without allowing the public to comment in the required public input.
- 53. The Council votes on the sub item 18 without public input.
- 54. I was prepared to speak in the vaccine issue but not given an opportunity.
- 55. My rights were violated by the persons responsible for conducting the meeting under the laws of the state of South Dakota, city of Sioux Falls ordinances, procedures and Robert's Rules of the body by the presiding officer (the mayor), the City Clerk (as parliamentarian required to guide the body to follow laws and rules cited), City Attorney (required to guide the body to follow laws cited) and the City Council Chair (required to use the laws cited) to maintain a lawful meeting.
- 56. At 12:50 minutes (<a href="https://youtu.be/-bSgqDzUyMo?t=770">https://youtu.be/-bSgqDzUyMo?t=770</a>) the Clerk reads the item for DCK, LLC from Exhibit C sub agenda Item 12 and discussion and questioning starts.
- 57. Questioning and discussion of sub item 12 DCK, LLC from Exhibit C to Agenda ends when presiding officer TenHaken calls for a motion at 20:55 minutes (<a href="https://youtu.be/-bSgqDzUyMo?t=1255">https://youtu.be/-bSgqDzUyMo?t=1255</a>) without allowing public input.
- 58. I was not allowed to express my concerns on this issue as required under the rules of the body, state law or ordinance of Sioux Falls.
- 59. I was one of three members of the public who attended the meeting to speak on this issue.
- 60. The city knew of our concerns for this issue by virtue of my explicit requests to the administration of Paul TenHaken through Jamie Palmer, the licensing specialist.
- 61. Councilor Pat Starr had the item moved from the consent agenda specifically due to my personal request to him.
- 62. My rights were violated by the persons responsible for conducting the meeting under the laws of the state of South Dakota, city of Sioux Falls ordinances, procedures and Robert's Rules of the body by the presiding officer (the mayor), the City Clerk (as parliamentarian required to guide the body to follow laws and rules cited), City Attorney (required to guide the body to follow laws cited) and the City Council Chair (required to use the laws cited) to maintain a lawful meeting.
- 63. I contacted Jamie Palmer, city of Sioux Falls Licensing Specialist who presented the item at the meeting for procedures on how I could to speak to my issues now that the Council had voted immediately after the vote concluded.
- 64. I began to SMS text messages informing others including City Council members of my intention to speak at the item public input about my concerns regarding the bar's license.

- 65. The list of people I informed via SMS text messaging include:
  - a. Council member Curt Soehl Chair of City Council
  - b. Bridgett Meyers
  - c. Council member Greg Neitzert former Chair of City Council
  - d. SD Rep. Greg Jamison former Chair of City Council
  - e. Council member Marshall Selberg former Chair of City Council

  - g. Randa Heller
  - h. Scott Ehrisman publisher, www.southdacola.com
  - i. Bruce Danielson publisher, www.siouxfall.org
- 66. Near the end of the meeting, during the general public input portion of the agenda, I informed the official dais and viewing public of the violations to the open meetings laws at 3:39:36 (<a href="https://youtu.be/-bSgqDzUyMo?t=13172">https://youtu.be/-bSgqDzUyMo?t=13172</a>).
- 67. While I was giving my public input on the violations and why I would be filing an open meetings complaint, the presiding officer Mayor Paul TenHaken started laughing at my comments.
- 68. I nearly called him out as I was speaking, but rules of the body do not allow us to call out the actions of members of the dais.
- 69. I notified the above list of dais members, people on the above SMS list and others of my intention to file this affidavit documenting the open meetings violations with the proper authorities on the evening of November 16<sup>th</sup>, 2021.
- 70. I spoke to agenda items during the general public input portion of the meeting because my rights were neglected during the item discussions and prior to the voting.
- 71. My rights were violated at least twice by the persons responsible for conducting the meeting under the laws of the state of South Dakota, city of Sioux Falls ordinances, procedures and Robert's Rules of the body by the presiding officer (the mayor), the City Clerk (as parliamentarian required to guide the body to follow laws and rules cited), City Attorney (required to guide the body to follow laws cited) and the City Council Chair (required to use the laws cited) to maintain a lawful meeting.
- 72. On November 19th, 2021 I filed a forms compiling with notice required under SDCL 3-21-3(3) LIABILITY OF PUBLIC ENTITIES AND PUBLIC OFFICIALS with the City of Sioux Falls informing the city of my claim of harm.
- 73. With this Affidavit of Sierra Broussard, I have attached a SDCL 3-21 Notice of Harm, a November 16<sup>th</sup>, 2021 Sioux Falls City Council meeting minutes, applicable City of Sioux Falls Charter sections and ordinances, South Dakota Constitution Article IX Home Rule. The Sioux Falls City Council has separate rules and procedures not readily accessible to the public not included.
- 74. Stacy Kooistra should have recused himself as has been his policy and practice on other issues involving the Sioux Falls Police Department due to a close family connection as his brother is a senior officer with the department.
- 75. I ask that Daniel Hagger, Minnehaha County States Attorney recuse himself from any involvement with this Open Meetings violation due to his recent employment and associations

with the Sioux Falls City Attorney Office.

76. I ask that the Minnehaha County States Attorney Office recuse in its entirety, due to potential conflicts involving personnel with recent employment and associations with the Sioux Falls City Attorney Office.





# **Background of Sioux Falls city government**

The city of Sioux Falls is led by a mayor–council (strong mayor) form of government. Mayoral elections occur every four years. City council seats are also contested every four years. Not all councilmembers are elected in the same year, as the elections are staggered throughout even-numbered years. The council consists of five members elected to represent specific sections of the city and three additional seats that represent the city as a whole (At-Large). The councilmember position is designed to be part-time.

Sioux Falls is a political subdivision of the state of South Dakota operating under Article IX, Local Government § 2 Home rule, as permitted by the South Dakota constitution.

South Dakota's constitution allows home rule governments to exercise any function not prohibited by the state constitution, the general laws of the state, or the charter of the home rule government.

Sioux Falls voted to be a Home Rule Charter community by public vote in 1994. Sioux Falls shall not make law less stringent than federal or state law and is allowed to pass ordinances more stringent.

#### South Dakota Constitution, Article IX, Local Government § 2 Home rule

§ 2. Home rule. Any county or city or combinations thereof may provide for the adoption or amendment of a charter. Such charter shall be adopted or amended if approved at an election by a majority of the votes cast thereon. Not less than ten percent of those voting in the last preceding gubernatorial election in the affected jurisdiction may by petition initiate the question of whether to adopt or amend a charter.

A chartered governmental unit may exercise any legislative power or perform any function not denied by its charter, the Constitution or the general laws of the state. The charter may provide for any form of executive, legislative and administrative structure which shall be of superior authority to statute, provided that the legislative body so established be chosen by popular election and that the administrative proceedings be subject to judicial review.

Powers and functions of home rule units shall be construed liberally.

# Sioux Falls Home Rule Charter

#### • Section 2.03 Mayor.

The mayor shall serve as a member of the city council. In the absence of the mayor for purposes of city council meetings, the city council shall designate one (1) of its members as acting mayor, with the duties but not the powers of that office. In case of emergencies or for purposes of day-to-day administrative duties and functions if the mayor is temporarily unavailable, the mayor shall propose to designate an interim successor by executive order, listing not less than three (3) nor more than seven (7) interim successors. The selection of interim successors in the executive order shall be at the mayor's discretion from among department heads or city employees; however, the number and order of proposed interim successor designees shall not be effective without the advice and consent of the city council.

The city council shall appoint an officer of the city who shall have the title of city clerk. The city clerk shall give notice of council meetings to its members and the public, keep the minutes of its proceedings and perform such other duties as are assigned by this charter or by the council or by state law.

#### • § 30.014 AGENDA

- (a) All materials related to an agenda item requiring council action will be delivered to the city clerk's office in its complete and final format.
- (b) At the request of any one council member, an item may be removed from the consent agenda and placed on the regular agenda whenever that council member believes additional discussion on the item is necessary.

- (c) The proposed agenda shall be posted at the city clerk's office and placed on the city's website. An email notice shall also be sent to all persons who have requested notice pursuant to law by the close of business on the Friday preceding any meeting to take place on the following Tuesday. Proposed additions to the agenda, in their complete and final format, including a signed agenda approval form, shall be delivered to the city clerk's office no later than Monday at 12:00 p.m. before the Tuesday meeting the next day. These items shall be listed as "Items added after agenda deadline" on a revised agenda which shall be posted, placed on the website and noticed at least 24 hours in advance of the Tuesday meeting to the council, the mayor, the directors and all persons who have requested notice pursuant to law. The sponsor(s) of any item added after the agenda deadline shall provide an email notice to the city council members and the city clerk's office by 4:00 p.m. the day prior to consideration by the city council. The notice shall include a statement regarding the background and objective of the proposed item and shall be posted to the city's website by the city clerk's office upon its receipt. However, the provisions of this section do not apply to any information that is specifically exempt from disclosure under state public record laws in effect at the time. Additional printed material may be distributed to the governing body in accordance with SDCL 1-27-1.16. A technological problem or failure that either prevents the posting of public notices on a website or that temporarily or permanently prevents the use of all or part of the website does not preclude the holding of the meeting for which the notice was posted, if the public body complies with all other public notice requirements.
- (d) During consideration of new business, the mayor or any two city council members may bring before the city council any business that person feels should be deliberated upon by the city council. These matters can be added to the agenda by a vote of six city council members and will be considered under new business. Formal action on these matters shall be deferred until a subsequent city council meeting, unless consideration is necessary for the immediate preservation of the public peace, health or safety of the municipal government. If the city council chooses to take immediate action on the newly calendared agenda item, an affirmative vote of six members of the council is required for approval.

#### • § 30.015 ADDRESSING THE COUNCIL; TIME LIMIT.

- (a) Public input shall be allowed for any item on the regular agenda. Each person addressing the city council shall step up to the microphone in front of the rail, shall give his or her name in an audible tone of voice for the record, and unless further time is granted by the presiding officer, shall be limited to three minutes on any ordinance receiving a first reading; and on the date of final adoption by the city council, five minutes shall be allowed. The city council has the right to overrule the presiding officer's use of discretion pursuant to *Robert's Rules of Order Newly Revised* (latest edition).
- (b) Notwithstanding division (a) above, the general public input portion of a city council meeting, held pursuant to § 30.001(b) will be limited to topics which do not involve those agenda items

appearing earlier in the regular agenda as public input shall be received when that agenda item is up for discussion. Each person addressing the city council during the general public input portion shall be limited to three minutes.

- (c) No person shall address the city council without first securing the permission of the mayor, or acting mayor, to do so.
- (d) Electronic presentations with audio and video embedded within the electronic presentation shall not be allowed. Electronic presentations without audio and video embedded within the electronic presentation are only permitted during regular agenda items on the date of final adoption. The city council may adopt standards that govern the use of electronic presentations. This provision shall not be construed to restrict electronic or hardcopy photos from being presented by the public during a regular meeting.
  - (e) All remarks shall be addressed to the city council as a body and not to any member thereof.
- (f) No person, other than the city council and the person having the floor, shall be permitted to enter into any discussion, either directly or through a member of the city council without the permission of the mayor or acting mayor.
- (g) No question shall be asked of a city council member except through the mayor or acting mayor.
- (h) No person, except city council members, shall address the council after a motion is made and seconded unless requested by a city council member.
